In the event of a **SERIOUS INJURY, ILLNESS, FIRE, POLICE, CALL 911** and continue with appropriate first aid training, care and/or Action as necessary. When the ambulance arrives, pull the person's record and give pertinent information to the ambulance personnel. While awaiting the ambulance call Management as listed below. Continue to move through the list until you reach a member of Management. The following list of names and locations represents the responsible person at the designated location.
